



1 Introduction

The legal system in Greece is expressed through 2 types of Governmental decisions: the laws and the Presidential Decisions. Both of them are considered as active since the moment of publishing the above in the official Publication of the Greek Government which is signed by the President of Democracy. All of the above get an official and unique numbering and consist of many articles that have a unique number, eg. Law 1234/1994 Article 4 means the article No4 of the Law Numbered 1234 of the year 1994.

In some cases there are some Formal Decisions that have the effect of a law, although there are not laws, eg Decision No17/2008 of the Central Fire Service. Those cases are rare. The above have national wide effect within the Greek territory without any exception. The European Directives in order to be effective in Greece need to take the form of a Greek Law and until the courts need to follow the already existing Greek Laws.

The social security organizations have also their Formal Decisions in order to fulfil their role and obligations against the workers (like accidents compensations, expecting mother's protection, etc). The main complexity of the Greek regulation system is that when there is a need to update the content of an article in a Law, this can be done with a new reference in an article of another newer law. In this way, you can have a law describing for example the main principles of the H&S at work and many other newer laws consisting of selectively updating articles of the initial referenced law. This makes quite difficult to keep up to date the changing history of a law and its articles.

In this overview, there is an overview of the already known and existing legislation, but please consider that if needed we need to search field by field the laws and the updated per article.
